Jumbo purchased 37,522,422 shares at SGD0.26 per share by way of an off-market acquisition on an equal access scheme on 11 March 2024. Kuang Ming did not participate in the equal access scheme. Out of the 37,522,422 shares purchased, 29,975,722 shares were cancelled and 7,546,700 shares are held as treasury shares, resulting in a change in the number of issued shares (excluding treasury shares) of Jumbo and consequently, a percentage level change in the relevant Substantial Shareholders' interest in Jumbo.
